ORDER

This Civil Revision petition is filed seeking for a direction to the III Additional District and Sessions Court, Thirupattur to dispose of the First Appeal in A.S.No.23 of 2018 within a time frame fixed by this Court.

3. The main suit is for partition. Challenging the preliminary decree for partition passed in the suit, the defendants 1 to 3 have filed the appeal in A.S.No.23 of 2018. The Revision petitioner who was the 5th defendant in the

suit was arrayed as 3rd respondent in the Appeal. Therefore, this Court is inclined to issue a direction to the Court below to dispose of the First Appeal in A.S.No.23 of 2018 within a period of three months from the date of receipt of copy of this order. This Civil Revision petition is accordingly disposed of. No costs.
