On 14.12.2021, this Court passed the following order:

“Mr.R.Muniyapparaj, learned Additional Public Prosecutor takes notice for the respondent/State.

In the meanwhile, the Registry is directed to put up a note, as to whether the appellant herein has filed any appeal through any other counsel, challenging his conviction and sentence dated 29.11.2016 passed by the Sessions Judge, Fast Track Mahila Court, Villupuram in S.C.No.16 of 2015.

Registry is directed to call for a report from the trial Court, as to whether records and material objects in the said Sessions Case are still available.

Post this matter on 11.01.2022.”

2. Pursuant to the above order, the Registry has put up a note dated 10.01.2022, wherein, it has been stated as follows:

3. In view of the above and being satisfied with the reasons assigned in the affidavit filed in support of this petition, the delay of 1161 days in filing the above appeal is condoned.

Accordingly, this criminal miscellaneous petition stands allowed. The Registry shall number the appeal, if the same is otherwise in order.
