However, till date no orders have been passed. Hence, this writ petition is filed with the aforesaid prayer.

4. The learned counsel appearing for the petitioner submitted that the it would suffice, if this Court issues direction to the respondent to consider the petitioner's representation dated 13.07.2022 and pass appropriate orders within a reasonable time fixed by this Court.

5. The learned Additional Government Pleader appearing on behalf of the respondent submitted that the petitioner's representation dated 13.07.2022
