2. When the matter was taken up for hearing, Mrs.Chithra Sampath, learned senior counsel appearing on behalf of the third respondent submitted that the order of interim injunction has been suspended by this Court by an order dated 11.01.2022 and the order was also produced before this Court.

In view of the above, the directions that were issued to the second respondent will stand terminated and it will be left open to the parties to agitate their rights/grievances in the pending civil proceedings. It is made clear that any observations made by this Court while passing the orders in



the writ petition will not have any bearing and the parties are entitled to put forth all their claims without being impacted by the orders passed in writ petition.

4. In view of the above, this Contempt Petition is closed.
