The learned counsel for the petitioner submitted that the petitioner gave a complaint against one T.V.Nadarajan and his family members which was taken on file by the learned XXIII Metropolitan Magistrate, Saidapet in CMP.No.7070 of 2022 and on 30.06.2022 the trial Court forwarded the same to the respondent police to register a case.
