ORDER

This writ petition has been filed challenging the transfer order dated 16.09.2022 issued to the petitioner transferring him from Hosur to Vellore.

2. Today, when the matter is taken up, learned counsel for the petitioner, on instructions, would submit that the petitioner is willing to join duty at the transferred place as per the impugned order provided he is allowed to give a representation to the official respondents requesting them to transfer him either to his original place or at Kaveripattinam and the said representation is considered on merits and in accordance with law, as and when any vacancy arises.

3. As no prejudice is going to be caused to the respondents, if such a direction is issued in this case, the writ petition is disposed of in the following manner.

4. The petitioner is directed to join duty at the transferred place ie, Vellore, as per the impugned order dated 16.09.2022 within a period of one week from the date of receipt of a copy of this order. On joining duty, within a period of one week, the petitioner is directed to give a representation to the official respondents requesting them to re-transfer him to his original place or Kaveripattinam as and when any vacancy arises in any of the said

such a representation, the official respondents shall pass final orders on the said representation on merits and in accordance with law within a period of two weeks from the date when a vacancy arises in Kaveripattinam or the petitioner's previous place of posting prior to the impugned transfer.
