PRAYER: Petition filed under Article 226 of the Constitution of India, for issuance of Writ of Mandamus directing the 2nd respondent to pass necessary orders on the petition dated 04.12.2021 in accordance with law, to cancel correct the patta Nos. 3241,3242,3243,3244 wrongly issued by 3rd respondent to Respondents 5 to 7 herein and consequently issue patta to the petitioner in respect of land having an extent of 2400 sq. ft bearing Plot No.247 in Ganga Garden C comprised in S.No.48/6, in No.150 Santhavellore Village, Sriperumbudur Taluk, Kancheepuram District, within limits of SRO Walajabad, Kancheepuram Registration District and bounded on North by plot No.248, South by Plot No.246 East by 23 feet Road and west by Plot No.252, after getting a report from 3rd and 4th Respondent under the Tamil Nadu Survey and Boundaries Act, 1923 within a time limit stipulated by this Hon'ble Court and pass orders.

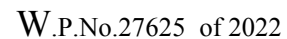

the third respondent who is a competent authority to decide the issue. He further submits that if the petitioner files a fresh petition before the third respondent under the provisions of Tamil Nadu survey and Boundaries Act, 1923 , the same will be considered in accordance with law.

6. Heard both sides and perused the materials available on record.

7. In such view of the matter this petition is dismissed. However the petitioner is at liberty to file a fresh application before the third respondent in terms of Tamil Nadu survey and Boundaries Act, 1923 within a period of four weeks from the date of receipt of a copy of this order and if any such application is filed the third respondent is directed to dispose of the same after providing opportunity to the petitioner and 5th respondent within a period of twelve weeks from the date of filing of such application.
