The petitioner who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 4(1)(a) & 4(1-A) of TN Prohibition Act, in Crime No.220 of 2022 on the file of the respondent police, seek anticipatory bail.

2. The case of the prosecution is that the petitioner was in possession of 40 liters of I.D. Arrack. Hence the case.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent person and he is no way connected with the alleged offence. Hence he prays to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl.side) appearing for the respondent would submit that the investigation is not yet completed and if the petitioner is granted anticipatory bail, there is a possibility that he will tamper the witnesses and hamper the investigation. He would further submit that there are 2 cases of similar nature pending as against the petitioner and hence he vehemently opposed to grant anticipatory bail to the petitioner.
