Therefore, the first respondent is directed to consider the representations of the petitioners dated 27.11.2017 and 25.06.2022 and pass appropriate orders on the petitioner's representations to survey, fix the boundaries and add common passage for the land comprised in Survey No.447/2 in Field Measurement Book at Karunguzhi Village, Maduranthakam Taluk, Chengalpattu District as per parent registered as Document No.966/2003, on merits and in accordance with law after providing opportunity of hearing to the petitioner as well as any other parties, within a period of twelve weeks from the date of receipt of copy of this order, on payment of requisite fees.
