Prayer in W.P.No.27446 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the first respondent to dispose of the petitioners appeal dated 19.07.2022 pertaining to property bearing Survey Nos.294/1F1B located at Kandamanadi Revenue Village, Villupuram Taluk, Villupuram District admeasuring 130 sq.mts within a time frame and pass orders.

Prayer in W.P.No.27449 of 2022: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the first respondent to dispose of the petitioner's appeal dated 19.07.2022 pertaining to property bearing Survey Nos.334/4A1 located at Kandamanadi Revenue Village, Villupuram Taluk, Villupuram District admeasuring 247 sq.mts. within a time frame and pass orders.

COMMON ORDER

4. The case of the petitioners are that the 2nd Respondent had acquired their lands and passed an award on 31.08.2021 wherein the compensation amount awarded is very meagre. Being not satisfied with the award passed by the 2nd respondent the petitioners filed appeal before the first Respondent. However, till date no orders have been passed. Hence, the petitioner have filed these writ petitions with the aforesaid prayer.

5. The learned counsel appearing for the petitioners submitted that the it would suffice, if this Court issues direction to the first respondent to dispose of the appeals filed by the petitioners as early as possible.

6. The learned Government Advocate appearing on behalf of the respondents submitted that the orders will be passed in the appeals filed by the petitioners as early as possible.

7. Considering the limited request made by the petitioners, this Court is inclined to direct the first respondent to dispose of the appeals filed by the

petitioners on 19.07.2022 within a period of twelve weeks from the date of receipt of a copy of this order after affording an opportunity of hearing to the petitioners as well as counter parties if any.
