Hence, the petitioner has filed this writ petition with the aforesaid prayer.

4. The learned counsel appearing for the petitioner submitted that the it would suffice, if this Court issues direction to the first respondent to dispose of the appeal filed by the petitioner as early as possible.

5. The learned Government Advocate appearing on behalf of the respondents submitted that the orders will be passed in the appeal filed by the
