ORDER

(Order of the Court was made by P.N.PRAKASH, J.)

Challenging the steps that were taken by the Government to evict the petitioners from a water body, the petitioners filed W.P. No.10738 of 2012, questioning the validity of G.O.Ms.No.313 Revenue (Ni.Mu.1) dated 23.05.2005. In the said writ petition, the First Bench, by order dated 15.12.2016 has held as under:

2. The learned counsel for the petitioners has not been able to persuade us as to how pattas can be given in respect of the land in question in view of the aforesaid impediment.

3. The learned counsel for the petitioners faced with the aforesaid position states that the petitioners had vacated the original site on a premise that they would be rehabilitated by issuance of patta and if patta cannot be issued in respect of the land in question, then the petitioners may be rehabilitated in



with liberty to the petitioners to work out their remedies in the manner known to law.
