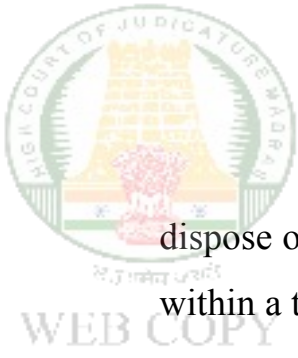

### **ORDER**

2. In view of the order proposed to be passed, which would not cause any prejudice to the Third to Ninth Respondents, notice to them is dispensed with.

3. The Petitioner has sought for a direction to the First Respondent to dispose the appeal in A.P. No. 102/2022-D2 filed before the First Respondent under Section 54(4) of the Tamil Nadu Hindu Religious and Charitable Endowments Act, 1959, within a time frame as may be fixed by this Court.

It is expected that the concerned parties shall extend their fullest co-operation for expeditious disposal of the appeal before the First Respondent.

In fine, the Writ Petition is ordered on the aforesaid terms. Consequently, the connected Miscellaneous Petition is closed. No costs.
