This Criminal Original Petition has been filed to direct the respondent to register an FIR pursuant to the complaint dated on 08.08.2022.

The learned counsel appearing for the petitioner submitted that though the petitioner gave complaint on 08.08.2022 with regard to the removal of iron gate from the petitioner's property, the respondent police has not registered a case till now. Therefore, the respondent police may be directed to register the case, based on the compliant given by the petitioner.
