3. No prejudice would be caused to the respondent, if such a direction is issued by this Court.

For the foregoing reasons, this writ petition is disposed of by directing the respondent to pass final orders on the petitioner's representation dated 26.04.2022 seeking for revocation of the impugned suspension order dated 08.01.2021 in the light of G.O. Ms. No.81, Human Resources Management (N) Department, dated 04.08.2022, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

5. With the aforesaid directions, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
