The petitioner who apprehends arrest at the hands of the respondent police for the offences punishable under Sections 4(1)(aaa) r/w 4(1-A) of TNP Act in Crime No.120 of 2022, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner along with other accused were found in illegal possession of 110 litres of ID arrack. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the petitioner is an innocent person and he has been falsely implicated in this case. Hence, he prays for grant of anticipatory bail to the petitioner.

4.Per contra, the learned Government Advocate (Crl. Side) would submit that the petitioner is a habitual offender and that there are three previous cases similar in nature, pending against the petitioner. Hence, he vehemently opposed for the grant of anticipatory bail to the petitioner.
