## **ORDER**

The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural event viz., Adal Padal( Song and Dance) program to be held on 12.11.2022 between 06.00 p.m to 11.00 p.m., in connection with Arulmigu Sree Athanur Amman Temple Festival at A.Ayipalayam Village, Rasipuram Taluk, Namakkal District by considering the petitioner's representation dated 07.10.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 12.11.2022 between 06.00 p.m to 11.00 p.m, in the temple festival at Arulmigu Sree Athanur Amman Temple Festival at A.Ayipalayam Village, Rasipuram Taluk, Namakkal District, the petitioner has sent a representation, dated 07.10.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.Side), appearing for the

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 07.10.2022 and pass suitable orders based on the above said circular.
