2. Heard Mr.A.Tamilarasan, learned counsel appearing for the petitioner, Mr.P.Baladhandayutham, learned Special Government Pleader, appearing for the first respondent and Mr.J.Subbiah, learned Government Advocate (Criminal Side), appearing for the second respondent.

The petitioner submitted a representation before the first respondent on 12.11.2021 to survey the property ad-measuring 3.00 acres in Survey No.16/2A in Joint Patta No. 949 situated at No. 4, Veerapandi Village, Coimbatore District.
