Considering the same, the second respondent is directed to issue notice to the petitioner and the fourth respondent herein on the application filed by the petitioner within a period of two weeks from the date of receipt of copy of this order and conduct enquiry after giving them opportunity of hearing and pass orders on merits and in accordance with law within a period of twelve weeks thereafter.

3. With the above direction, this writ petition is disposed of. No order as to costs.
