2. The learned Government Advocate appearing on behalf of the respondents 1 and 2 made a submission that the impugned order dated 24.02.2017 has already been recalled by the Department. Thus, the cause did not exist. That apart, the writ petitioner has already attained the age of Superannuation on 31.03.2020 and allowed to retire from service.

3. Thus, no further adjudication is required and accordingly, the writ petition stands closed. No costs. Consequently, connected miscellaneous petitions are closed.
