The present petition has been filed seeking modification in respect of the condition imposed in clause (a) of para 7 of the order dated 02.11.2021.

Upon hearing the learned counsel for the petitioner, this Court is of the opinion that no further modification is required in the said order passed by this Court, since the petitioner, on his own volition undertook to deposit the amount. Such being the case it is not open for the petitioner to contend that the condition is onerous and seek modification



Accordingly, the petition seeking modification petition is dismissed.
