ORDER

The Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 31.10.2022 at 6.00 pm onwards in connection with the Temple Festival of Arulmigu Sri Chinna Mariamman Temple, Singalandhapuram Village, Rasipuram Taluk, Namakkal District by considering the petitioner's representation dated 19.10.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 31.10.2022, from 6.00 p.m. to 11.00 p.m., in the temple festival at Arulmigu Sri Chinna Mariamman Temple, Singalandhapuram Village, Rasipuram Taluk, Namakkal District, the petitioner has sent a representation, dated 19.10.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a circular memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 19.10.2022 and pass suitable orders based on the above said circular.
