Virudhachalam-Salem National Highway Marginal Road No.532, which is comprised in S.No.85/1 in Kezhkuppam Village, Chinnasalam Taluk, Kallakurichi District, by considering the petitioner's representation dated 25.02.2022.

2. When the matter was taken up, Mr.P.Muthukumar, learned State Government Pleader appearing for the respondents 1 to 3, placing on record the written instructions from the Divisional Engineer, National Highways, Villupuram dated 16.11.2022, stated that the alleged encroachment in Survey No.85/1 in Kezhkuppam Village, Chinnasalam Taluk, Kallakurichi District said to have been made by the 5th and 6th respondents was already inspected and after ascertaining with the Survey Department, if any encroachment is found, the alleged encroachers will be evicted within 30 days, as per law.

3. Placing on record the written instructions aforementioned, the writ petition stands disposed of granting six weeks time to the official
