The Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 02.11.2022 at 6.00 pm onwards in connection with the Temple Festival of Arulmigu Sri West Chinna Mariamman Temple, Singalandhapuram Village, Rasipuram Taluk, Namakkal District by considering the petitioner's representation dated 25.10.2022.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 25.10.2022 and pass suitable orders based on the above said circular.
