The Writ Petition has been filed to direct the respondent to grant permission and police protection to conduct the cultural event viz., Adal Padal (Song and Dance) program to be held on 02.11.2022 at 6.00 pm onwards in connection with the Temple Festival of Athipalaganur Village Arulmigu Sree Mariyamman Temple Festival at Rasipuram Taluk, Namakkal District by considering the petitioner's representation dated 22.10.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 02.11.2022, from 6.00 p.m. to 11.00 p.m., in the temple festival at Athipalaganur Village Arulmigu Sree Mariyamman Temple Festival at Rasipuram Taluk, Namakkal District, the petitioner has sent a representation, dated 22.10.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 22.10.2022 and pass suitable orders based on the above said circular.
