ORDER

Whiles, the concerned Village Administrative Officer is orally intimidating the petitioners to vacate him from the subject property as the said land belongs to Government for which the petitioner sent a representation to the respondents on 07.09.2022. However till date no action was taken. Hence, the present writ petition.
