ORDER

The Criminal Original Petition has been filed, seeking a direction to the 2nd respondent police to conduct an enquiry on the basis of the petitioner's complaint dated 03.10.2022 and register the same within the time frame stipulated by this Court.

2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondents 1 and 2.

3. The learned counsel appearing for the petitioner submitted that the petitioner has lodged a complaint by alleging job racketing committed by the accused. But, so far, no action has been taken by the 2nd respondent and no FIR has been registered.

4. The learned Government Advocate (Crl. Side) submitted that the current paper enquiry has been initiated in C.S.R No.771 of 2022 on the complaint given by the petitioner and further enquiry is pending in this regard.
