ORDER

The Writ Petition has been filed, seeking to issue a Writ of Mandamus directing the respondent to give permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of Chinnathambipalayam Village Arulmigu Sree Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District on 10.11.2022 between 6.00 p.m to 11.00 p.m by considering the petitioner's representation dated 28.10.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 10.11.2022 between 06.00 p.m to 11.00 p.m, in the event of Chinnathambipalayam Village Arulmigu Sree Mariyamman Temple Festival at Tiruchengode Taluk, Namakkal District, the petitioner has sent a representation, dated 28.10.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a circular memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 28.10.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.
