Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 29.10.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.
