2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondents.

The learned counsel for the petitioner submitted that he had given a representation on 13.10.2022 to the second respondent police to issue “No Objection Certificate” to run the business of Massage Parlour, SPA, Beauty Parlour in the name and style of “Ellan Wellness Spa” in the above mentioned address; but the said representation was not considered so far.
