2.Heard the learned counsel for the petitioner and the learned Government Advocate (crl.side) appearing for the respondents.

3.The learned counsel for the petitioner submitted that there is a land dispute between the petitioner's family and the family of one Kumar; the wife of Kumar, by name Shanthi is a Village Panchayat President; by making influence of the said post, the said Kumar has given the complaint against the petitioner and in view of that, the petitioner is being harassed by the respondent police.

4. The learned Government Advocate (crl.side) appearing for the respondents submitted that the petitioner has given a complaint against
