ORDER

This Writ Petition has been filed seeking for a mandamus to direct the respondent to give permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of Sri Madurai Veeran Temple Festival, Singipuram Village, Valapadi Taluk, Salem District on 08.11.2022 at about 6.00p.m by considering the petitioner's representation dated 29.10.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 08.11.2022 at about 06.00p.m, in the event of Sri Madurai Veeran Temple Festival, Singipuram Village, Valapadi Taluk, Salem District, the petitioner has sent a representation dated 29.10.2022 to the respondent. But the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.Side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 29.10.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.

6. With these observations, this Writ Petition is disposed of.
