When it was pointed out that the representation dated 09.05.2022 has been made by the Petitioner to the Second Respondent for allotment of bunk shop, but the concerned authority is the Third Respondent and separate lists are maintained for each vending zone, Learned Counsel for the Petitioner seeks permission of the Court to withdraw the Writ Petition reserving the right of the Petitioner to make necessary application to the concerned authority of the
