3. The learned counsel for the petitioner submitted that the case has been registered in the year 2009 and so far, no action has been taken and the long pendency of the investigation is a kind of harassment given to the petitioner.

4. The learned Government Advocate (Crl.Side) submitted that since the Government Servants are involved in the case, the delay is probably due to mandatory sanction that has to be obtained for the prosecution.
