ORDER

The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Temple Festival of Rasipuram Arulmigu Sree Nithiya Sumangali Amman Temple, Rasipuram Taluk, Namakkal District on 12.11.2022 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 04.11.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 12.11.2022 between 06.00 PM to 11.00 PM, in the temple festival at Rasipuram Arulmigu Sree Nithiya Sumangali Amman Temple, Rasipuram Taluk, Namakkal District, the petitioner has sent a representation, dated 04.11.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 04.11.2022 and pass suitable orders based on the above said circular.

With the above direction, this Writ Petition is **disposed of**. No costs.
