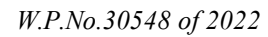

4. The case of the petitioner is that the petitioner is the purchased the land and the same was registered vide Sale Deed Doc.No.1104 of 1983. The grievance of the petitioner is that the subject land was never sub-divided. Hence the petitioner made a representation dated 03.11.2022. along with documents before the first and second respondents requesting to survey the land of the petitioner, but the same was not considered. Hence this writ petition.

5. The learned counsel for the petitioner submitted that this Court may issue a direction to the first respondent to consider the petitioner's representation dated 03.11.2022. within the stipulated time as fixed by this Court.

6. The learned Additional Government Pleader would submit that the petitioner's representation dated 03.11.2022. will be considered on merits and in accordance with law.
