2.The learned counsel appearing for the petitioner submitted that the petitioner is the owner of the subject property, however, the respondents are trying to evict the petitioner from the property, without due process of law, which is not sustainable.

3.The learned Additional Government Pleader appearing for the respondents submitted that the entire property is Boomi Dhan land

belonging to Tamil Nadu Boomi Dhan Board, however, the petitioner's possession will be interfered with only by following due process of law.
