The Writ Petition has been filed, seeking to issue a Writ of Mandamus directing the respondent to give permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of Ekkatampalayam Village Arulmigu Sree Mariyamman Temple Festival at Perundurai Taluk, Erode District on 07.12.2022 between 6.00.p.m to 11.00.p.m by considering the petitioner's representation dated 05.11.2022.
