According to the petitioner, as per the recommendations of Seventh Central Pay Commission, her pay ought to have been revised in the light of G.O.Ms. No. 303 Finance (Pay Cell) Department dated 11.10.2017. Though she gave a representation on 25.05.2022 for the said purpose, the same has not been considered till date. Hence, she has filed the present writ petition.

3. Heard the learned counsel for the petitioner, the learned Special Government Pleader for the first respondent and the learned Additional Government Pleader for respondents 2 to 5.

4. No prejudice is going to be caused to the respondents if the petitioner's representation is directed to be considered in accordance with law within a stipulated time.

5. For the foregoing reasons, this Court directs the 4th respondent to pass final orders on merits and in accordance with law on the
