ORDER

This Writ Petition has been filed seeking a direction to the second Respondent to dispose of petitioner's application dated 29.08.2022 for UDR patta corrections.

2. The case of the petitioner is that the petitioner inherited the subject property from his grand mother. Whiles the revenue officials entered the name of the 5th respondent who is one of the legal heir of the petitioner's grandmother and other legal heir names were not entered. Hence the petitioner gave a representation on 29.08.2022 to the second respondent to rectify the said error. However the same was not considered. Hence this petition.

In view of the above, this Court directs the second respondent to consider the representation dated 29.08.2022 and pass appropriate orders on merits and in accordance with law, after providing opportunity to the petitioner as well as counter parties if any within a period of twelve weeks from the date of receipt of a copy of this order.

7. With the above directions, the writ petition is disposed of. No costs.
