ORDER

By the consent of both the parties this writ petition is taken up for disposal at the admission stage itself.

2. The case of the petitioner is that the subject land was assigned to the petitioner and thereafter there was series of litigation by the other assignees, land owners and subsequent purchasers. However, the assignment made to the petitioner was not carried out in the revenue records. Hence the petitioner made a representation to the respondent on 22.09.2022. However the same was not considered. Hence this petition.

3. The learned counsel for the petitioner submits that it would be suffice if this Court issues a direction to the respondents to consider the petitioner's representation dated 22.09.2022, within a stipulated time as
