2. The petitioners/Massage Centres have got qualified and trained therapist who are giving massage therapy to the people coming thereon. There is no immoral activities conducted in the petitioners' Centre. However, the respondent authorities frequently inspect the premises and interfere with their business. In this regard, the petitioners / Massage Centres have given a representation dated 07.11.2022 to the respondents. However no steps have been taken on the said representation. Hence, these Writ Petitions.

3. The learned Government Advocate (Crl.Side) appearing for the respondents would submit that the alleged representation dated 07.11.2022 will be considered in accordance with law.

4. Considering the submissions made by both sides, the respondents are directed to consider the representation submitted by the petitioners on 07.11.2022 and do the needful in accordance with law within a period of
