ORDER

2. The case of the petitioner is that the petitioner inherited the subject property from his father and he was in possession and enjoyment of the same. Whiles the revenue officials entered the name of the name of the second and third respondents herein as joint pattadhar in respect of the subject property Hence the petitioner gave a representation on 17.10.2022 to the first respondent to rectify the said error. However the same was not considered. Hence this petition.

3. Since no adverse order is passed against the private respondents notice to private respondents dispensed with.

4. The learned counsel for the petitioner submitted that it would be suffice if this Court issues a direction to the first respondent to consider the representation of the petitioner dated 17.10.2022 in terms of
