ORDER

This Criminal Original Petition has been filed seeking a direction to the 1st and 2nd respondents to provide police protection to the petitioner life and his house construction work in new survey No.164/3 old survey No.104 situated at Sembiamadevi Village, Kallakurichi District by considering the petitioner's representation dated 09.11.2022.

2.The learned counsel appearing for the petitioner submits that the petitioner had given a complaint dated 17.10.2022 to the second respondent police against the third respondent and others. On receipt of the same, the second respondent police registered a case in Crime No.235 of 2022 for offences punishable under Sections 448, 453, 427 & 506(2) IPC. However, when the petitioner had put up a construction, the third respondent interfered and disturbed the same. Therefore, further representation has also been given by the petitioner to the second respondent police as against the third respondent and her henchmen.
