ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Mulanur Village, Chinnaravalasu Arulmigu Sree Rajaganapathi, Pattatharasiyamman & Kaliyamman Temple Maha Kumbabishekam Festival at Dharapuram Taluk, Tiruppur District on 04.12.2022 between 06.00 PM to 11.00 PM by considering the petitioner's representation dated 15.11.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 04.12.2022 between 06.00 PM to 11.00 PM, in the event of Mulanur Village, Chinnaravalasu Arulmigu Sree Rajaganapathi, Pattatharasiyamman & Kaliyamman Temple Maha Kumbabishekam Festival at Dharapuram Taluk, Tiruppur District, the petitioner has sent a representation dated 15.11.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.Side), appearing for the respondent submitted that the respondent police has received the representation

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 15.11.2022 and pass suitable orders based on the above said circular.
