The petitioner who apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 8(c), 20(b)(ii)(A) of NDPS Act read with Section 77 of Juvenile Justice (Care and Protection of Children) Act, in Crime No.516 of 2022 on the file of the respondent police, seek anticipatory bail.

2. The case of the prosecution is that the petitioner along with the co-accused was found in possession of 300 gms of Ganja. Hence the case.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent person and he is no way connected with the alleged offence. Hence he prays to grant anticipatory bail to the petitioner.

4. The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioner is an habitual offender against whom there are four previous case pending. Hence, he vehemently opposed to grant anticipatory bail to the petitioner.
