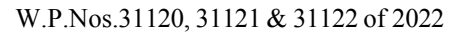
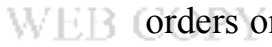

COMMON ORDER

Mr.Yogesh Kannadasan, learned Special Government Pleader accepts notice for the respondents and is armed with instructions to enable final disposal of these matters, even at the stage of admission.

The petitioner, who is a contract carriage operator running omni buses holding a permit issued under Sections 88(8) and 88(9) of the Motor Vehicles Act, 1988, prays for a mandamus directing the respondents, being the Transport Commissioner/R1 and Regional Transport Officer/R2 to refund the tax paid for the period between 24.3.2020 and 30.6.2020 or adjust the same towards future tax payable in respect of the petitioner's vehicles.

3. Since the identical prayer has been made in the representation dated 11.01.2021 before R1, it would be appropriate that this request be considered and disposed by the authorities, before whom the representation is pending.
