ORDER

This Writ Petition has been filed seeking for a mandamus to direct the respondent to give permission and police protection to conduct the cultural programme (Adal Padal Nigalchi) in the event of “Kurukkapatti Village Arulmigu Sree Poomariyamman Temple Festival” at Edapadi Taluk, Salem District on 06.12.2022 between 6.00p.m. to 11.00p.m. by considering the petitioner's representation dated 18.11.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 06.12.2022 between 6.00p.m. to 11.00p.m., in the event of "Kurukkapatti Village Arulmigu Sree Poomariyamman Temple Festival", at Edapadi Taluk, Salem District, the petitioner has sent a representation dated 18.11.2022 to the respondent. But the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (Crl.Side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner dated 18.11.2022 and pass suitable orders based on the above said circular. Uploaded copy can be utilized for the purpose of execution of the order.

6. With these observations, this Writ Petition is disposed of. No costs.
