4. Heard the learned counsel for the petitioner and Mr.U.M.Ravichandran, learned Special Government Pleader appearing for the respondents.

5. Though the petitioner has completed the PG Degree course only in 2022 and two years bond period is yet to be completed, the petitioner wants to give an undertaking to the third respondent institution that, after he joins and completes the Super Specialty Course, he is ready and willing to work with or serve the third respondent or any other institution at the instance of the third respondent.

6. In view of the aforesaid stand taken by the petitioner through the learned counsel for the petitioner, this Court is inclined to dispose of this writ petition with the following order.

- That the petitioner shall execute an indemnity bond with an undertaking that the two years bond period can be extended for further period of two years after the petitioner completes the Super Specialty Course for which he has been qualified now and after he completes the Super Specialty Course in Medicine, he would again serve the third respondent institution or any other institution at the instance of the third respondent institution for a period of two years.

- On receipt of such undertaking to be executed by the petitioner, the respondents shall release the original certificates held by them which were submitted by the petitioner along with the provisional certificate of the P.G.Degree course, enabling the petitioner to join in the Super Specialty Course.

7. With the aforesaid directions, this writ petition is disposed of. No costs.
