WP 23107 of 2017 is filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Mandamus, directing the respondent to treat the petitioners as regular employees/permanent employees of the respondent-Company with effect from 01.10.2010 as against the first and second petitioners and 16.02.2013 as against third and fourth petitioners in order to get the VRS benefits at the rate of 2007 Notional Pay Scale to the petitioners payable to other or remaining employees or any other VRS applicable and eligible to the remaining permanent/regular workers in the case of acceptance of VRS application submitted by the employees.

WP 25368 of 2017 is filed under Article 226 of the Constitution of India, praying for the issuance of a Writ of Certiorari, calling for the records relating to the order dated 27.03.2017, passed by the Deputy Director of Industrial Safety and Health, Udhagamandalam, The Nilgiris, the first respondent herein, in Na.Ka.No.A/451 of 2016 and quash the same.
